## **ABOUT THE GOVERNORS**

Governors are required to act in the best interest of the school as a whole, not to represent any particular interest group.

We are elected or appointed as follows:

**Parents** : Elected by parents; must have at least one child at the school at the time of election. Are representative parents, not representative of parents.

*Staff :* Elected by staff, must work at the school.

*Co-Opted* : Asked by Governors to bring special expertise to the Governing Body.

*Local Authority*: Nominated by the Local Authority but appointed by the Governing Body.

Head Teacher : The head teacher is a member of the Governing Body by virtue of their office.

Foundation: Appointed by the Dioceses.

Also Surrey County Council always have governor vacancies at other schools and would welcome any applications.

## What we do

Governors seek to maintain and improve standards of education. They contribute to the work of the Governing Body in ensuring high standards of achievement for all children and young people in the school by:

- . Setting the school's vision, and strategic direction;
- . Holding the Head Teacher to account for the educational performance of the school and its pupils; and
- . Overseeing the financial performance of the school and making sure its money is well spent.

All these have to be developed within the constraints imposed by National and Surrey County Council policies, and the funding received. Most importantly, it is the Head Teacher and staff who run the school – not the governors.
